1) Wood pellets (commodity code 4401 31 000 0). Used shipped wagons grain – industrial pellets (We can consider the possibility to deliver pellets by trucks in big bags).

Volume: Since June 2020 – 50 000 t/year (building of 5 new pellet plants);

Diameter - 6-8 mm;

Density - 1,13 kg/dm³

Humidity - 9,5%;

Ash content - 1,0%;

Bulk density - 675 kg/m³

Calorific value - 17,0 MJ/kg

Dust content during abrasion of pellets – 2,6%

Sulfur - 0,01%

Chlorine – 0,01%.

2) Wood pellets premium quality (commodity code 4401 31 000 0). Used shipped wagons grain (We can consider the possibility to deliver pellets by trucks in big bags, packaging polyethylene bags 15 kg.).

Volume: Since June 2020 – 15000 t/year (building of 1 new pellet plants);

Diameter - 6 mm.
